Supervisor Blouvet stated that Recycling for Cuba has more Recycling than Friendship, as it was weighed out. The Recycling Company won't pay any money for the recycling; there is no money in it. Supervisor Blouvet also stated he has not signed any contract with Casella.

Supervisor Blouvet stated that County wants 30,000 gals of water/day from Friendship to Belvidere. The Town's Engineer is working on the plan. Legislator Healy was updated on the Town's priorities, that the Town's water situation would be taken care of first and then they will look into the Resolution to provide crossroads with the water. The USDA will not help us until we have a plan in place.

The Supervisor voiced concerns regarding Baldwin's accounting firm and the Departments not getting financial info when they need it. A suggested formal letter should be sent to Baldwin's.

PUBLIC CONCERNS

Donna VanCurren voiced concerns with her neighbor, Marie Lochner. She states trash is brought in there, music played all hours, that they have been living in a camping trailer for more than 30 days. She also complains that she has rats and claims they come from these people. Kevin Margerum has been up there multiple times and has found no trash on the property or has seen no rats. He thinks if there are rats, they are coming from the abandoned house that has been condemned and is owned by the County. He will check with the County on this house, thinking it should be demolished by them. Any other trailers on the Lochner property are supposed to be removed off the property. Mr. Margerum stated " he cannot regulate camping trailers under the Code. As far as property maintenance he does not see garbage, only construction debris, which was removed". Fred Cook went on to say that these people used to be good friends with Donna and she now just harasses them. He went on to say he thinks they may be moving.

Leslie Dahill states that there has been many complaints over the years on neighbors on Queen Ann St.

Fred Cook- stated his son owns 5 Howard and they had all new lines put in and had Darrell Stuck dig and put in new pipes, he claims there is still no water pressure in the house. He asked if the water dept. could somehow check the water flow to figure out where the problem is. Oakley Sortore stated he will take a look at it.
