A public hearing was held before the Town Board at <u>6:30</u> P.M. to hear all persons interested in the matter of the adoption of the Introductory Local Law No. 3 of 2019 entitled "A Local Law to Override the Real Property Tax Cap Levy Established by General Municipal Law Section 3-c" for the purpose of enabling the Town Board to adopt a budget for 2020 that exceeds the 2019 real property tax levy by more than 2.00% within the Town of Friendship. The Deputy Supervisor explained how the proposed local law would operate and the reasons why the Town Board is considering adopting it. The Board members answered questions from those present for the public hearing. The Deputy Supervisor declared the public hearing to be closed.

Following the close of the public hearing the Town Board considered the adoption of the proposed local law for which the public hearing had earlier been held. The Deputy Supervisor asked for a resolution that the proposed local law be adopted. The following resolution was made by <u>Jill Hoopes</u>, who moved its adoption, and seconded by <u>Carolyn Carney</u>, to wit:

WHEREAS, the Town Board of the Town of Friendship, Allegany County, State of New York, has determined that the adoption of this local law is necessary for the purpose of enabling the Town Board to adopt a budget for 2020 that exceeds the 2019 real property tax levy by more than 2.00% within the Town of Friendship; and

WHEREAS, the Town Board of the Town of Friendship desires to provide for a budget for 2020 that exceeds the 2019 real property tax levy by more than 2.00%;

NOW, THEREFORE, be it resolved that the Town of Friendship adopt Local Law No. 3 of 2019 entitled "A Local Law to Override the Real Property Tax Cap Levy Established by General Municipal Law Section 3-c," which local law shall provide as follows:

Section 1. Legislative Intent.

It is the intent of this local law to override the limit on the amount of real property taxes that may be levied by the Town of Friendship, pursuant to General Municipal Law Section 3-c, and to allow the Town of Friendship to adopt a budget for fiscal year 2020 that requires a tax levy increase in excess of the "tax levy limit" as defined by General Municipal Law Section 3-c.

Section 2. Authority.

This local law is adopted pursuant to subdivision 5 of General Municipal Law Section 3-c, which expressly authorizes the Town Board to override the tax levy limit by the adoption of a local law approved by a vote of sixty percent (60%) of the Town Board.

Section 3. Tax Levy Limit Override.

The Town Board of the Town of Friendship, County of Allegany, State of New York, is hereby authorized to adopt a budget for fiscal year 2019 that requires a real property tax levy in excess of the amount otherwise proscribed in General Municipal Law Section 3-c. This override is necessary to deal with the following increased costs:

- increased health insurance costs pursuant to the Collective Bargaining Agreement that the Town is obligated to pay pursuant to the State Taylor Law;
- increased wages for Town employees pursuant to the Collective Bargaining Agreement that the Town is obligated to pay pursuant to the State Taylor Law;
- c. increased fuel and other operating costs that impact critical and necessary operations of the Town Highway Department;
- d. increased operational costs for refuse collection services;
- e. increase in employee to Public Works Department; and
- f. increased expenses for the repair and replacement of storm drains;

g. increased costs for ambulance and Town Court due to decrease in ambulance revenue and Town Court fees.

Section 4. Severability.

If any clause, sentence, paragraph, subdivision, or part of this Local Law or the application thereof to any person, firm or corporation, or circumstance, shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision or part of this Local Law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

Section 5. Effective Date.

This local law shall take effect immediately upon filing with the Secretary of State pursuant to Section 27 of the Municipal Home Rule Law. The Deputy Supervisor asked if there was any further discussion. There being no further discussion the Deputy Supervisor put the matter to a roll call vote which resulted as follows:

DEPUTY SUPERVISOR CONCERNS-

INCORRECT 911 SIGNS

Deputy Hall who also works for the 911-numbering center is here to talk about the wrong address numbering in Friendship. There are some wrong issued addresses and he wants to know if the Board thinks the Town should order and pay for the corrected posts for the land owners. He explained that Allegany County and Nationwide have a new 911 center. Technology has changed and there is a missing link to the 911 center to convert the roads and address data nationally to GPS. He has been going door to door comparing what people are using to what has been assigned. The incorrect address people are using have to be correct to go into the GPS for the 911 center to have the correct address.

In the Town Budget there is no line area for the cost for the change of address signs, so what line should it come form if the Board decides to pay for the corrected signs. New signs will still be paid for by the owner (1st time signs); this is just for the wrong signs that need to be corrected. It could be a liability for the Town if it is known the address is wrong and we let the owner know and we do not issue and put in the new correct sign. It was decided because there's not designated line that any cost would be taken out of the Contingency line. Russell Hall will put new signs in.
