Supervisor Hall advised he met with Senator Borello and he advised he was told that the State is cutting back on 20% on all funding for the 2021 tax season. All grants are being held up. CHIP money has not been released yet. Per Mike Bidwell, Hwy Superintendent advised he can't spend more than the CHIPS brings in, you have to have that money in your budget.

2021 will be tough on small municipalities.

Councilperson Carolyn Carney advised she had some complaints on Austin Road and back roads with the 4 wheelers. O.I. C. B.J. Howe advised with Labor day weekend coming up he will make sure he has police force on duty.

Councilperson Linda Mascho has complaint about Fred Cook's property on Maple Ave. where they have been having a barn sale on that property. Its not safe, the house is half demo'd. It was promised that it

would be taken down years ago. The Code Enforcement is currently working on this, as well as other properties in Town.
