Steve Ritter questioned if the Dog Law should be changed to limit the number of dogs a household Can have. It was mentioned that there is a household now that has 22 dogs. All have their rabies shots and have been licensed. Supervisor Hall advised there will have to be a discussion with Dog Control Regarding this before any changes to the Local law.

## Public Works-

Refuse- Russell Hall advised that the Town lost a bunch of Refuse workers, 2 Drivers and 2-pickers. They don't get many hours, its part time. He states we will have to figure it out. Other Towns are having a hard time getting drivers or workers, other places are having to offer wages above what they currently make The State makes it hard for a person to get a CDL and its expensive, positions also have to be approved at the County level.

Questions: can the Town create somehow a fulltime position shared by both the highway and public works(universal person). How do we fund this in the middle of the budget year. Maybe the refuse workers that want to quit can be offered an increase of pay to stay. Carolyn Carney questioned also the possibility of contracting the garbage out. Recycling was also brought up by Oakley Sortore, he stated only about 25% of the people recycle. Suggestion that individual could just buy a garbage pass or hire someone on their own. Until a solution Supervisor Hall stated that Belmont stated they would help out, but it is a sacrifice for them.
