Annual Drinking Water Quality Report for 2021

INTRODUCTION

To comply with State regulations, The Town of Friendship, will be annually issuing a report describing the quality of your drinking water. The purpose of this report is to raise your understanding of drinking water and awareness of the need to protect our drinking water sources. Last year, your tap water met all State drinking water health standards. We are proud to report that our system did not violate a maximum contaminant level or any other water quality standard. This report provides an overview of last year's water quality. Included are details about where your water comes from, what it contains, and how it compares to State standards.

WHERE DOES OUR WATER COME FROM?

In general, the sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activities. Contaminants that may be present in source water include: microbial contaminants; inorganic contaminants; pesticides and herbicides; organic chemical contaminants; and radioactive contaminants. In order to ensure that tap water is safe to drink, the State and the EPA prescribe regulations which limit the amount of certain contaminants in water provided by public water systems. The State Health Department's and the FDA's regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

Our water system serves 1380 people through 575 service connections, Our water sources are wells. Our wells are: Sunnyside Street Well #1, Pennsylvania Avenue Well #4 and #5, AquaMag, a blended phosphate is added to the water to Sequester Iron and Manganese, as well as aid in corrosion control. The water is chlorinated prior to distribution.

A copy of the source water's susceptibility to contamination will be made available for review at the town hall. This report evaluates the potential for contaminants to enter the groundwater pumped by the well.

ARE THERE CONTAMINANTS IN OUR DRINKING WATER?

As required by State regulations, we routinely test your drinking water for numerous contaminants. These contaminants include: total coliform, turbidity, inorganic compounds, nitrate, nitrite, lead and copper, volatile organic compounds, total trihalomethanes, and synthetic organic compounds.

The table presented below depicts which compounds were detected in your drinking water. The State allows us to test for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. Some of our data, though representative, are more than one year old.

^{*}The State considers 50 pCi/l to be the level of concern for beta particles.

**The level presented represents the 90th percentile of the 20 sites tested. A percentile is a value on a scale of 100 that indicates the percent of distribution that is equal to or below it. The 90th percentile is equal to or greater than 90% of the lead and copper values detected at your water system. In this case, 20 samples were collected at your water system and the 90th percentile values were the values indicated above. The action level for lead was not exceeded at any of the sites tested. The action level for copper was not exceeded at any of the sites tested.

The low level for copper was 0.0278 and the high level was 0.764 The low level for lead was < 0.001 and the high level was 0.0017

DEFINITIONS:

 $\underline{\text{Micrograms per liter (ug/l)}} = \text{Parts per Billion (ppb)}$

<u>Picocuries per liter (pci/l):</u> The measure of the radioactivity in water

<u>Maximum Contaminant Level Goal (MCLG)</u>: The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLG's allow for a margin of safety.

Action Level (AL): The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

⁺Water containing more than 20 mg/l of sodium should not be used for drinking by people of severely restricted sodium diets. Water containing more than 270 mg/l of sodium should not be used for drinking by people on moderately restricted sodium diets.

<u>Milligrams per liter (mg/l)</u>: Corresponds to one part of liquid in one million parts of liquid (Parts per Million – ppm)

<u>Maximum Contaminant Level (MCL)</u>: The level of a contaminant that is allowed in drinking water. MCL's are set as close to the MCLG's as feasible.

<u>Maximum Residual Disinfectant Level (MRDL):</u> The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

<u>Maximum Residual Disinfectant Level Goal (MRDLG):</u> The level of drinking water disinfectant below which there is no known or expected risk to health. MRDLG's do not reflect the benefits of the use of disinfectants to control microbial contamination.

Million Fibers Per Liter (MFL): filtered to <0.16 million fibers per liter and longer than 10 microns.

Non Detected (ND): no contaminants were detected within the testing parameters.

WHAT DOES THIS INFORMATION MEAN?

As you can see by the table, our system had no violations. We have learned through our testing that some contaminants have been detected; however, these contaminants were detected below current federal drinking water requirements. Although arsenic was detected below the MCL, it was detected at (6.7 Ug/l) which is greater than one-half of the MCL. Therefore, we are required to present the following information on arsenic in drinking water:

"NYS and EPA have promulgated a drinking water arsenic standard of 10 parts per billion. While your drinking water meets the standard for arsenic, it does contain low levels of arsenic. The standard balances the current understanding of arsenic's possible health effects against the costs of removing arsenic from drinking water. EPA continues to research the health effect of low levels of arsenic, which is a mineral known to cause cancer in humans at high concentrations and is linked to other health effects such as skin damage and circulatory problems."

IS OUR WATER SAFE FOR EVERYONE?

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer, undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the risk of infection by cryptosporidium, giardia and other microbiological contaminants are available from the Safe Drinking Water Hotline.

WHY SAVE WATER AND HOW TO AVOID WASTING IT?

Although our system has an adequate amount of water to meet present and future demands, there are a number of reasons why it is important to conserve water:

 Saving water saves energy and some of the costs associated with both of these necessities of life.

- Saving water reduces the cost of energy required to pump water and the need to construct costly new wells, pumping systems and water towers.
- Saving water also lessens the strain on the water system during a dry spell or drought, helping to avoid severe water use restrictions so that essential fire fighting needs are met.

You can play a role in conserving water by becoming conscious of the amount of water your household is using and by looking for ways to use less whenever you can. It is not hard to conserve water. Conservation tips include:

- Loading your dishwasher to capacity. Automatic dishwashers use 15 gallons for every cycle, regardless of how many dishes are loaded.
- Turn off the tap when brushing your teeth. Check every faucet in your home for leaks. Just a slow drip can waste 15 to 20 gallons a day. Fix it up and you can save almost 6,000 gallons per year.
- Check your toilet for leaks by putting a few drops of food coloring in the tank, watch for a few minutes to see if the color shows up in the bowl. It is not uncommon to lose up to 100 gallons a day from one of these otherwise invisible toilet leaks. Fix it and you save more than 30,000 gallons a year.
- Use your water meter to detect hidden leaks. First check the reading on the meter and then simply turn off all taps and water using appliances. Then check the meter after 15 minutes. If it moved, you have a leak

SYSTEM IMPROVEMENTS

In 2022 we plan to upgrade or repair fire hydrants, and valves in certain areas of the distribution system and reduce water loss through continued leak detection efforts and correction. We hope to finalize the installation of the CrossRoads Water Main, and tie in any of the interested residents. We are making improvements to our main well facility to provide for better redundancy.
